Dear Parents/Care Givers,

We are required to seek parental consent to websites and applications with students in the teaching and learning program. This can be any site or application where names of students may be entered, including those programs we already have subscriptions for across the school or across phases within the school. These websites or applications are known as third party services.

In the following sections on the applicable form, we will indicate the reasons why we use the service, what information will be required, who may have access and where the data is stored. Additional consent will be required with new third party services or if the risk assessment conducted by the Department of Education changes to a higher level.

Parents with multiple children must complete individual forms for each child.

Four types of risk assessments:

- No consent required.
- Notification of 'Minimal Risk' services.
- Bundled consent for 'Low Risk' services.
- Individual consent for 'Medium Risk' services.

Please ensure you read, and then sign for permission to be granted for use and return to your child's teacher. Please note that, given the significant education benefits that these services provide, the school will contact you to discuss your reasons should you not consent or fail to provide a response.
